

The First Party and the Second Party have agreed to the following terms and conditions of the agreement:

1. The college (First Party) shall allow the use of its premises to Lakhimpur District Taekwon-Do Association(Second Party) for training purposes in the time and days as decided mutually. An official permission letter should preferably be issued by the College authority to the District Association.
2. The instructor and District Association shall ensure that no unlawful activity will be conducted in the premises in the class hours. But the instructor and District Association shall not be responsible for whatever happens in the premises in the class hours.
3. The college should allow the District Association to conduct other related activities besides regular classes (Eg. Belt examination, workshop, seminars,) for the welfare of the students. The District Association should give prior information to the college authorities in this matter before the event.
4. The revenue sharing shall be as per the discussion between the District Association and the college authorities. (Annexure A)
5. The class fees shall be collected by the instructor or the college as mutually decided.
6. Instructor in the institute shall be appointed by the District Association of TAA (ITF). The District Association has the right to change instructor in the institution for the smooth conduct of the classes. The appointed instructor shall work on behalf of the District Association and Taekwon-Do Association Assam (ITF).
7. Affiliation Fees shall be paid annually by the college (whoever conducts the classes and collects the fees) to the District Association.
8. The college is not entitled to any amount from the Belt Examination Fees which is the sole jurisdiction of Taekwon-Do Association Assam (ITF).
9. The students are expected to maintain proper discipline in the class and wear proper uniform. The District Association has the right to debar any student from the class or belt exam if he/she violated the decorum of the class or fails to clear the dues after repeated reminders.
10. Fees to be paid by the students are as follows (As on Jan 2022):
