

In pursuance of the decision of the 302nd Meeting of the Executive Council, Dibrugarh University held on 17.06.2010 the Lakhimpur Girls' College, P.O. Khelmati, Lakhimpur is accorded permission to start :

Master Degree in Home Science w.e.f. the academic session 2010-2011 subject to fulfilment of the following conditions.:

- (i) To de-link the Higher Secondary section before starting the Course
- (ii) Three more teachers in Home Science with UGC norms be appointed one each in subject Food and Nutrition, Family Resource Management Clothing and Textile, Extension Education.
- (iii) More books related to Master Degree Course in Home Science shall have to be procured.
- (iv) To subscribe at least one research journal in each of the subject.
- (v) Audio-Visual teaching aids, viz, Computers, LCD projector, etc. shall have to be procured.
- (vi) One Laboratory room shall have to be established with required instruments.
- (vii) One Early Childhood Education Centre with all psychological tools for practical classes of Child Development shall have to be established if Child Development is introduced as optional paper.
- (viii) Full-time / Part-time teachers for Statistics and Biochemistry shall have to be appointed.
- ~~(ix)~~ The intake of students shall not exceed **20 (twenty)**
- (x) Concurrence from the State Govt. of Assam shall be obtained by the College.
- (xi) The college shall submit an undertaking to comply with the above-mentioned conditions before commencement of the classes.
