Subject

Raising the Upper Age Limit for entry into State Government Service for Grade-III and Grade-IV posts from 38 years to 40 years.

- 1. The undersigned is directed to invite attention to the instructions contained in this Department's O.M. NO.AAP.115/72/Pt.I/194 dated 10-03-2008 and to state that after careful consideration of all aspects of the matter, the Government have decided to further raise the Upper Age Limit for entry into the State Government Service from 38 years to 40 years for Grade-III and Grade-IV posts. The Government have also decided to further raise the Upper Age Limit by 5 years over the general age Limit i.e up to 45 years from existing 43 years for entry into State Government Services in respect of candidates who belong to Scheduled Caste and Scheduled Tribes and by 3 years i.e. up to 43 years in respect of OBC/MOBC candidates, 2 years i.e. up to 42 years in respect of Ex-Servicemen and 10 years i.e. up to 50 years in respect of Persons With Disabilities.
  - The contents of the aforesaid O.M.'s may be treated as modified to the
    extent indicated above only in so far as Upper Age Limit for entry into the State Government
    Services is concerned.
  - 3. There shall be no change in the procedure of recruitment or any relaxation of educational or other qualification or service conditions such as year or age of retirement, etc. This relaxation shall be applicable only to those candidates who have attained the necessary educational or other qualifications prior to crossing of their existing upper age limit of 40 years. The application of this O.M. will also be limited to vacant posts for which advertisements are made on or after the date of effect of this O.M.
  - This Department's O.M. No.AAP.115/72/39, dated 29-08-77 with regard to age of Non-Gazetted ranks of Police Department remains unchanged.
    - 5. This order will come into force from the date of issue of the OM.
